### Outcomes After Default Judgment

Out of the **178 Default Judgments**, **93 Stores were shut down** by the marketplaces after the plaintiffs obtained court orders.

The remaining **85 Stores** were still active as of **July 2, 2025** — but most had **very low sales activity** (as shown by minimal feedback or ratings in the past 12 months). These stores were likely considered **not worth the cost** of enforcement by Motorola's legal team.

In contrast, larger sellers — particularly **DHGate stores** based overseas — may still be undergoing trial or litigation, which could explain why some high-volume stores are still operational despite a default judgment.

#### C Seller Lawsuit Shield's Role

SellerLawsuitShield.com successfully assisted 6 of the 52 released defendants in getting completely dismissed from the case, avoiding default judgments and protecting their stores.

We also reached out to several sellers who **chose not to accept our help** — some assumed the lawsuit was a scam or waited too long. Unfortunately, many of those sellers went on to receive default judgments and had their stores shut down permanently.

### Why This Matters

This document offers a real-world breakdown of what happens in Schedule A lawsuits:

- ✓ Timely response can result in full dismissal
- 💢 Ignoring the lawsuit leads to a default judgment
- 🔯 Not every default leads to a shutdown but most do
- 🔀 Larger sellers may remain active due to pending litigation

### \* Educational Purpose

This case is presented as a real example of the consequences and choices sellers face in Schedule A lawsuits. For privacy, some store names of released defendants have been redacted.

Salomon Decl., ¶ 4. Neither Plaintiffs nor the Court has granted the Defaulting Defendants an extension of time to respond to the Complaint. Id., ¶ 5. # DECLARATION OF LEIGH SALOMON IN SUPPORT OF PLAINTIFFS' REQUEST FOR CLERK'S ENTRY OF DEFAULT

I, Leigh Salomon, declare and state as follows:

- 1. I am over 18 years of age, and I have personal knowledge of the facts set forth herein. I make this declaration in support of Plaintiffs' Request for Entry of Clerk's Entry of Default against Defendants listed on the Schedule A attached to Plaintiffs' Request (the "Defaulting Defendants"). If called upon to do so, I could and would competently testify to the following facts set forth below.
- 2. On November 13, 2024, Plaintiffs filed their Complaint against Defendants, the Individuals, Corporations, Limited Liability Companies, Partnerships, and Unincorporated Associations Identified on Schedule A (collectively, "Defendants").
- 3. On March 12, 2025, pursuant to the methods of service authorized by the Court, all Defaulting Defendants were served via email and website posting with their respective Complaint.

- 6. The Defaulting Defendants have failed to respond to the Complaint.
- 7. I have no reason to believe that either any of the Defaulting Defendants are infants or incompetent persons or that the Servicemembers' Civil Relief Act applies.
